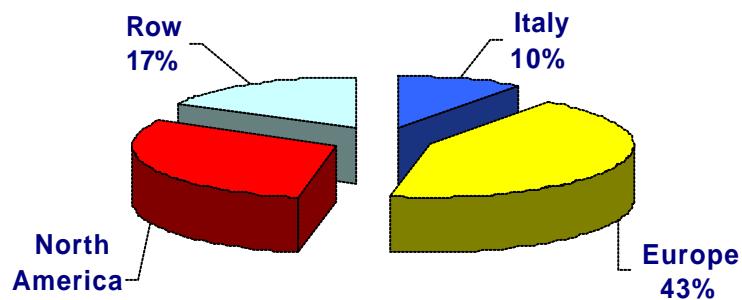
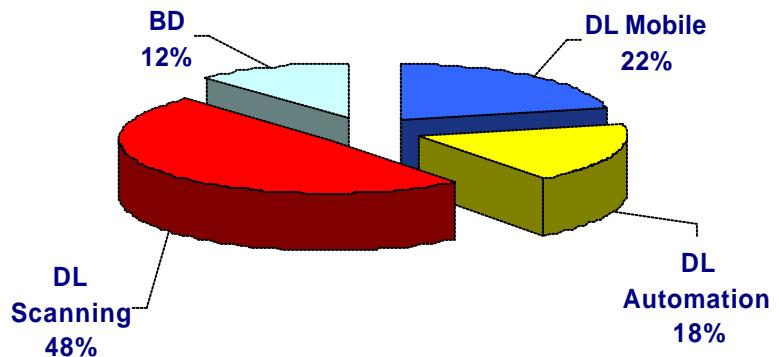

1H07 REVENUES BY GEOGRAPHIC AREA

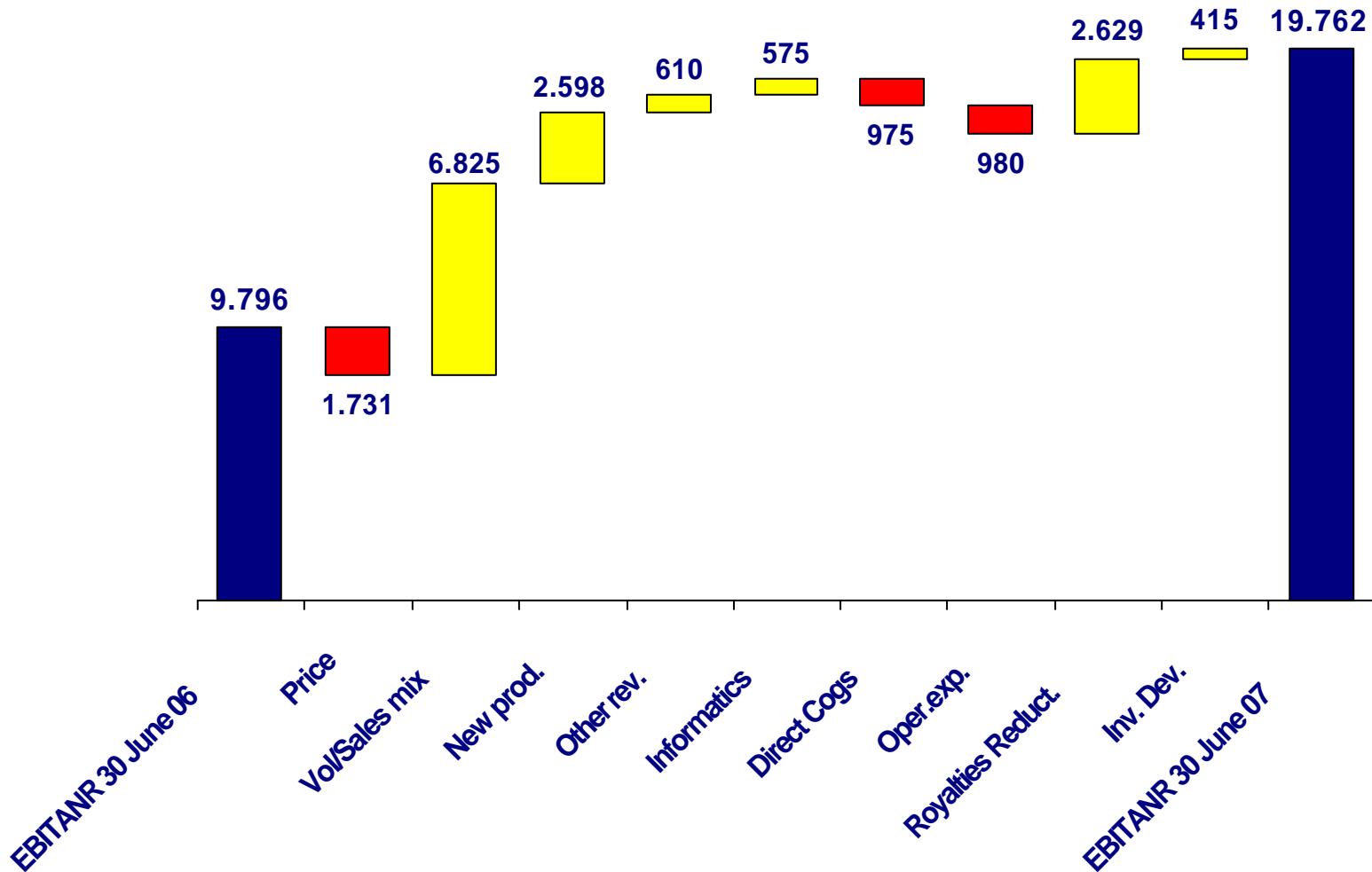

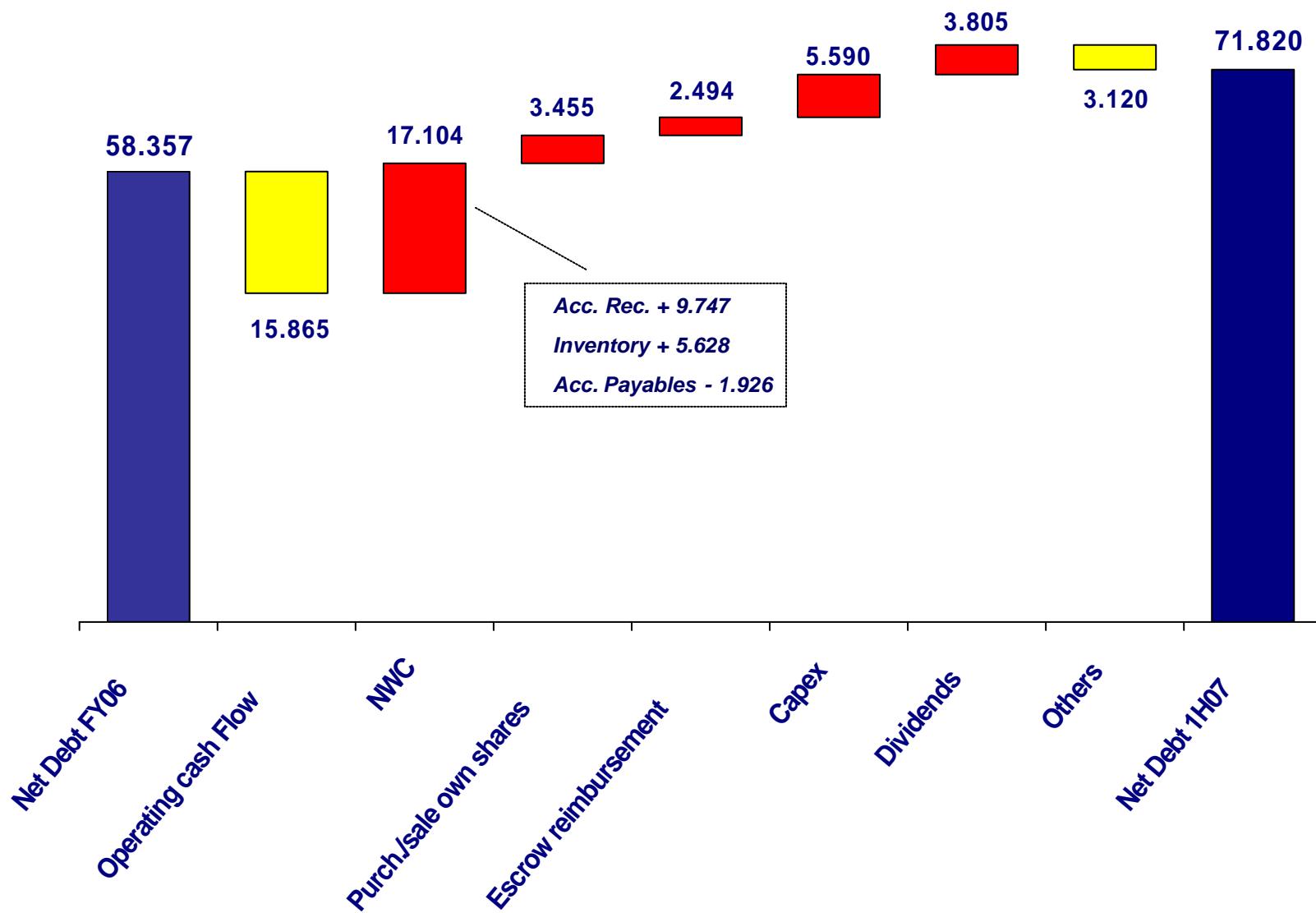
